

## Intergenerational equity in Paris Agreement

# **The Paris Agreement**

Acknowledges that climate change is a common concern of humankind, Parties should, when taking action to address climate change, respect, promote and consider their respective obligations on human rights, the right to health, the rights of indigenous peoples, local communities, migrants, children, persons with disabilities and people in vulnerable situations and the right to development, as well as gender equality, empowerment of women and intergenerational equity.

#### Aims

- The aim of the convention is described in Article 2, "enhancing the implementation" of the UNFCCC through:
- "(a) Holding the increase in the global average temperature to well below 2 °C above pre-industrial levels and to pursue efforts to limit the temperature increase to 1.5 °C above pre-industrial levels, recognizing that this would significantly reduce the risks and impacts of climate change;
- (b) Increasing the ability to adapt to the adverse impacts of climate change and foster climate resilience and low greenhouse gas emissions development, in a manner that does not threaten food production;
- (c) Making finance flows consistent with a pathway towards low greenhouse gas emissions and climate-resilient development."
- Countries furthermore aim to reach "global peaking of greenhouse gas emissions as soon as possible".

Intergenerational equity

- The actions and inactions of the present population can jeopardise the rights and well-being of generations yet to come. By delaying climate change action, we risk passing on an irreparably diminished legacy.
- The destruction of the environment is a fundamental breach of the principle because it will cause significant flow-on effects to present and future communities.

#### Derecho Internacional y la equidad intergeneracional

Codified in International Law in Principle III of the Rio Declaration on Environment and Development reminds us that it is the intergenerational partnerships that guarantee sustainability and long-term success. Therefore, "to ensure that the integral functionality of the climate of the land is not compromised for future generations; whose fundamental rights and interests must be treated with the same value as those of our generation "... is our priority.



The global frameworks recognise the importance of protecting our world for future generations and ensuring intergenerational equity. However, while there are now over 200 international agreements and UN General Assembly resolutions which recognise the need to safeguard the wellbeing of future generations, there is **no** mechanism by which the interests of future generations are represented in current decision making processes.
